

## **Call for Facilitator to support the development of child-led media awareness-raising campaign with the i-RESTORE Child Advisory Board members in Romania**

**Start date:** August

**Location:** Romania

**Deadline to apply:** preferable until 4 August 2021 (the call can be closed if a suitable candidate is found before this deadline, but the recruitment is on-going until the consultancy is filled)

### ABOUT TERRE DES HOMMES

Terre des hommes (Tdh) is the leading Swiss organisation for children's aid. Since 1960, Tdh has helped build a better future for vulnerable children and their communities, making an impact with innovative and sustainable solutions. Active in around 40 countries, Tdh works with its own teams and/or local and international partners to develop and implement field projects which significantly improved the daily lives of over four million children and members of their communities in 2019, in the domains of health, protection and emergency relief.

Through our Access to Justice programme, we encourage states in Europe to provide effective access to justice for children in contact with the law. We support the implementation of non-custodial measures for children and of stronger procedural safeguards. With our partners, we promote the use of restorative justice processes in cases involving children, either as victims or suspects/offenders. Through innovative methodologies, we engage with children to ensure that we understand their views. At regional level, we facilitate the sharing of best practices and learning, awareness-raising and advocacy for child-friendly justice. We also support the creation of the Barnahus multi-disciplinary service that provides care for child victims and witnesses of violence and abuse.

### ABOUT i-RESTORE

Tdh Regional Office in Hungary is leading the project "i-RESTORE - Better Protecting Child Victims Rights through Restorative Justice" (September 2019 until August 2021). The project's main objective is to promote the use of Restorative Justice in cases involving child victims by improving knowledge amongst national stakeholders on child-victim friendly Restorative Justice and empowering children to advocate for better protection of child victims.

### OBJECTIVE OF THE CONSULTANCY

Terre des hommes needs to develop a child-led awareness-raising campaign using media and art with the i-RESTORE Child Advisory Board ("CAB") members in Romania. To raise awareness among the general public, the CAB members will be supported by the Contractor in order to be able to develop their own

messages and written, audio and video material as part of a national awareness-raising campaign in Romania. The materials of this campaign should be produced taking inspiration from the Tdh YouCreate methodology, a course that the Contractor is expected to follow before starting this consultancy.

The consultancy has the following specific objectives:

- ♣ Conduct one session on the use of media and art for awareness-raising with the i-RESTORE CAB members in Romania
- ♣ Conduct two sessions on the development of materials with the i-RESTORE CAB members in Romania for the awareness-raising campaign
- ♣ Conduct two coaching sessions on public speaking and two on media and art for the i-RESTORE CAB members in Romania.

The Contractor will work under the supervision of the Regional Project Coordinator of i-RESTORE and the local coordinator of i-RESTORE in Romania. EXPECTED DELIVERABLES The expected deliverables are the following:

All dates might be slightly adjusted upon agreement between Tdh Romania. All sessions and materials should be produced in Romanian; however, reports for proof of delivery should be produced in English.

#### CONTRACTOR PROFILE

Candidates can apply as:

- a) An individual service provider, able to issue invoices with tax registration in Romania;
- b) An agency/a company, able to issue invoices with tax registration in Romania.

Candidates should have:

- Advanced degree in the field of communication, social work, education, psychology, or equivalent with strong training/capacity building skills;
- Proven experience in developing child-led awareness and advocacy campaigns and materials;
- Proven familiarity with media and advocacy in the field of children right's, able to conduct trainings on these topics;
- Excellent writing and communication skills, ability to communicate in a clear and sensitive manner;
- Excellent oral and written skills in both Romania and English.

#### BUDGET AND RESOURCES

The candidates are required to submit a financial offer, clearly indicating the total costs for this assignment. Prices should be expressed in EUR. Prices should be inclusive of all expenses, charges, taxes, including VAT, incurred by the Contractor in fulfilment of its obligations.

Tdh will also be responsible for logistical support, including room and equipment rental.

The payment will be issued upon approval of the final deliverable.
